Minutes – June 2, 2025 REGULAR CITY COUNCIL MEETING COUNCIL CHAMBERS-1111 AVE E, WISNER, NEBRASKA 68791

The City Council of the City of Wisner, Nebraska met in regular session in the Council Chambers at the City Offices in Wisner, Nebraska, on Monday, June 2, 2025, at 6:00 P.M. according to the notice published in the Wisner News Chronicle issue of May 29, 2025, a copy of the proof of publication is attached to these minutes. Notice of the meeting was posted in three public places which are the Wisner Post Office, Wisner Public Library, and the Wisner City Office. Notice of the meeting and the agenda were mailed or emailed to the mayor and all members of the City Council. A true copy of their signed acknowledgement of the receipt of the advance notice of this meeting and the agenda is filed in the office of the City Clerk/Treasurer. An agenda for the meeting was kept continuously current and was available for public inspection at the City Offices three days before the meeting date. Agenda subjects were contained at least twenty-four hours prior to the meeting. The mayor presided and the City Clerk/Treasurer recorded the proceedings of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the general public.

Mayor Soden called the meeting to order and announced the location of the posted Open Meetings Act, pursuant to Section 84-1412(8) of the Nebraska Open Meetings Act. Mayor Soden also announced that this meeting is being recorded.

Present on the roll call: Cathy Gobar, LJ Parker, Barry Meyer, Andrew Schweers, & Mayor Terry Soden. Staff present: Randy Woldt, City Administrator/Utility Superintendent, Stephanie James, City Clerk/ Treasurer, and Care Center Administrator, Sammye Nyman.

AGENDA ITEM NO. 1 – CONSENT AGENDA – AGENDA, MINUTES OF THE MAY 19, 2025 REGULAR MEETING, AND CARE CENTER, CITY, AND CITY/RURAL FIRE BOARD ACCOUNTS PAYABLES FOR JUNE 2025. Moved by Meyer and seconded by Parker to approve the consent agenda as presented. Roll call: Ayes: Meyer, Parker, Schweers, Gobar. Nay: None. Absent: None. Motion carried. Care Center payable total - \$191,888.59, and net payroll total for May - \$132,341.65, City payable total - \$1,132,364.51, and net payroll total for May - \$66,819.16, and City/Rural Fire Board payable total - \$5,151.95, be approved and allowed; and those warrants be drawn for their payment; and the City Clerk/ Treasurer publish said claims according to law; and an itemized account be kept on file in the office of the Wisner Care Center and Wisner City Office for public inspection. A copy of the signed acknowledgement of receipt and approval of each is attached to these minutes.

AGENDA ITEM NO. 2 – STREET DEPARTMENT – REVIEW OF THE ONE- AND SIX-YEAR STREET PLAN – TERRY MEAD, JEO. Terry Mead with JEO joined the meeting to explain and review with the public and council the One- and Six-Year Street Plan. Mr. Mead stated that he wanted to get the plan in front of the council for review so that there was time to make changes and have it ready for an August or September meeting to have a public hearing and approval so

that the plan can be turned into the state. Mr. Mead explained to the council the One- and Six-Year Street Plan and with out the plan the city will not be able to receive Highway Allocation Funds from the State of Nebraska. The city is not obligated to complete projects on the plan but if the city does complete a project, it should be moved to the One-Year plan. The plan can be amended after approval via a resolution. Councilman Schweers asked if a project is on the one-year plan does it need to be done. Mr. Mead stated that the state requires a plan for streets. The Highway Allocations Funds can only be spent on streets, such as repairs and replacement of streets. The city council did not have any other questions and Mr. Mead stated that if they have any questions, to please reach out to him. No action was taken.

AGENDA ITEM NO. 3 – DINKLAGE GRANT – DISCUSSION AND POSSIBLE ACTION REGARDING THE WISNER POLICE DEPARTMENT'S DINKLAGE GRANT APPLICATION. Councilman Meyer stated that the police department had a radio application last year and the Dinklage board turned it down because the board does not help fund infrastructure and that would be considered infrastructure for the police department and would probably be turned down again. Councilman Meyer went on to say that if the council wants to approve and turn it into the Dinklage Foundation we can. Moved by Parker to approve the Dinklage grant application submitted by the Wisner Police Department and forward it onto the Dinklage Foundation for final approval. Motion died due to a lack of a second. Motion denied.

AGENDA ITEM NO. 4 – UTILITY BILLING – REPORT ON RECEIVABLES. Stephanie James, City Clerk/Treasurer, stated that as of tonight's meeting, the past due amount is at \$3,148.88.

AGENDA ITEM NO. 5 – REVIEW BUILDING PERMIT APPLICATIONS. Randy Woldt, City Administrator/Utility Superintendent, stated he has one building permits at this time. The building permit is for the corner of Avenue F and Seventeenth Street for a new home.

AGENDA ITEM NO. 6 – COMMUNICATIONS, REPORTS, COMMENTS BY COUNCIL, CITY OFFICIALS AND GENERAL PUBLIC.

- A. Councilman Parker stated the pool is open and really busy and had their welcome to summer party. Things have been going good so far. There have been some questions as to why the pool is not open on Sunday's. It comes down to the number of lifeguards we have and their schedules. There are only about three guards that can work and Sundays are their slowest days and so the pool manager, Jamie decided to close that day. The splash pad is open and can be utilized. The splash pad was busy and benches are ordered and will be installed when they arrive. Councilman Barry stated that a reason for the pool being closed on Sundays should be in the paper. Councilman Parker stated that June will be really tough on pool hours and hope it gets better in July.
- B. Councilwoman Gobar asked if some trash cans can be placed down by the splash pad.
- C. Mr. Woldt showed the council a picture of a water fountain that Greg Rasmussen would like to purchase and donate to the Kids Fishing Pond to help aerate the pond. Mr. Woldt stated that the floors are rotting out of the outhouse restrooms and should be removed or replaced. Mr. Woldt said that WCD has a committee together to see

if there is funding available for a shower house to replace the outhouse. Mr. Woldt said that he was going to ask Al Vacanti to see if he too could help find some funding to replace the two damaged outhouse and replace with a nicer shower house for the park. Councilwoman Gobar asked how the restroom remodel was going at Central Park. Mr. Woldt stated that a sub-contractor hired by Stan Ortmeier and Company comes in on the evenings and works and then puts plywood back up on the doors and can not see the inside. Going back to the outhouses in the River Park, Mr. Woldt said the he will get the outhouses torn down and will replace them with a couple of portable restrooms for now. The portable restrooms at Central Park cost about \$130.00 a month and are cleaned out every two weeks.
